 GENTEXT/REMARKS/1. SITUATION. FSMAO WESTPAC WILL CONDUCT FORMAL ANALYSIS SCHEDULE IN ACCORDANCE WITH PARAGRAPH THREE OF THIS MESSAGE. DURING THIS PERIOD, FSMAO EAST AND FSMAO WEST HAVE TASK ORGANIZED TO EXECUTE TOTAL FORCE IMPLEMENTATION (TFI) OF GLOBAL COMBAT SUPPORT SYSTEM - MARINE CORPS (GCSS-MC) ALONG WITH COMPLIANCE ANALYSIS USING A REVISED CHECKLIST THAT FOCUSES ON EQUIPMENT ACCOUNTBAILITY, EQUIPMENT READINESS, AND EQUIPMENT READINESS REPORTING TO CONUS UNITS AND ALL ASSOCIATED ACTIVITY ADDRESS CODES (AAC). SPECIFIC DATES ARE SCHEDULED BASED UPON PUBLISHED GCSS-MC SEQUENCING GROUP FIELDING DATES. GCSS-MC IS THE TARGETED INFORMATION TECHNOLOGY SOLUTION AND THE ENTERPRISE INFORMATION TECHNOLOGY ARCHITECTURE AND PROGRAM OF RECORD THAT ALLOWS FOR THE RETIREMENT OF LEGACY SUPPLY AND MAINTENANCE APPLICATIONS (SASSY, MIMMS-AIS, AND ATLASS). CONCURRENTLY, FSMAO WILL SUPPORT THE CONDUCT OF NEW EQUIPMENT TRAINING (NET) AND CONDUCT COMPLIANCE ANALYSES THAT TARGET EQUIPMENT ACCOUNTABILITY, EQUIPMENT READINESS, AND READINESS REPORTING IN SUPPORT OF THE GCSS-MC IMPLEMENTATION EFFORT.
 2. MISSION. FSMAO SERVES AS THE DEPUTY COMMANDANT (DC), INSTALLATIONS & LOGISTICS' (I&L) DIRECT FIELD REPRESENTATIVE AND ADVOCATE TO EDUCATE AND TRAIN, IMPROVE PROCESSES, AND EVALUATE COMPLIANCE WITH DIRECTIVES AS THEY RELATE TO SUPPLY, MAINTENANCE AND MAINTENANCE MANAGEMENT WITHIN THE WESTPAC AREA OF RESPONSIBILITY. OIC, FSMAO WESTPAC WILL EXECUTE THE FY 2012 ANALYSIS SCHEDULE. FSMAO EAST AND FSMAO WEST WILL CONDUCT TFI FOR GCSS-MC WITH AN ABBREVIATED COMPLIANCE ANALYSIS AND CONDUCT NET FOR GCSS-MC TO SUPPORT DEVELOPMENT OF THE SYSTEM USER BASE TO UNITS WITHIN THE FSMAO EAST AND FSMAO WEST AOR'S UNTIL MISSION COMPLETION, ON OR ABOUT DECEMBER 2012.
 3. EXECUTION. FSMAO TEAM OIC WILL EXECUTE THE FOLLOWING ANALYSIS SCHEDULE FOR FY-2012. THIS SCHEDULE HAS BEEN COLLABORATIVELY DEVELOPED BETWEEN THE INDIVIDUAL MEF AND THE RESPECTIVE FSMAO TEAM OIC.
 3.A. FSMAO WESTPAC ANALYSIS SCHEDULE TO INCLUDE MFR UNITS FOR FY 2012. FSMAO-WP ANALYSES SCHEDULED FOR 1ST QTR FY12 HAVE BEEN DESIGNATED BY HQMC I&L (LPC) AS ASSIST VISITS VICE FORMAL ANALYSIS. FSMAO-WP WILL COORDINATE WITH III MEF G-4 AND MCBJ G-4 TO MAKE A RECOMMENDATION TO HQMC I&L (LPC) ON THE TRANSITION TO FORMAL ANALYSIS FOR 2ND THROUGH 4TH QUARTER FY12. PLEASE READ IN THREE COLUMNS. UNIT, RUC, SCHEDULED ANALYSIS DATES.

4. ADMINISTRATION AND LOGISTICS.

4.A. SCHEDULE CHANGES. REQUESTS FOR CHANGES TO THE APPROVED FSMAO ANALYSIS SCHEDULE WILL BE SUBMITTED TO THIS HEADQUARTERS DC IL (LPC) VIA THE CHAIN OF COMMAND BY NAVAL MSG.

4.B. TYPICAL FSMAO ANALYSES WILL SPAN A TWO-WEEK PERIOD; HOWEVER, THE FSMAO OICS HAVE THE FLEXIBILITY TO ADJUST THE ANALYSIS PERIOD BASED ON THE REQUIREMENTS OF THE UNIT ANALYZED.

4.C. FSMAO UNIT NOTIFICATIONS AND REPORTING REQUIREMENTS. THE FSMAO OIC WILL NOTIFY UNITS 30 DAYS PRIOR TO THE START OF ANALYSIS AND WILL PROVIDE COPIES OF ALL ANALYSIS CHECKLISTS. ONCE NOTIFIED, UNITS WILL COORDINATE REQUIREMENTS (IN-BRIEF, CONDUCT OF THE ANALYSIS, OUT-BRIEF) WITH THE FSMAO OIC. MAXIMUM EFFORT WILL BE MADE TO ENSURE THAT KEY UNIT PERSONNEL ARE AVAILABLE THROUGHOUT THE CONDUCT OF THE ANALYSIS (SUPO, SUPCHF, SUPPLYSHOP, MMO, MMC, COMMODITY OICS, AND RESPONSIBLE OFFICERS). THE NOTIFICATION LETTER WILL INCLUDE: DATES OF THE ANALYSIS, A TENTATIVE LIST OF THE FSMAO ANALYSIS TEAM MEMBERS, A LIST OF THE FUNCTIONAL AREAS BEING ANALYZED WITH APPROPRAITE CHECKLISTS, PROCEDURES/PROCESSES RELATIVE TO THE FSMAO FINAL ANALYTICAL REPORT AND REQUIREMENTS FOR UNIT CORRECTIVE ACTION AND REPORTING.

4.D. FINAL REPORT WILL LIST ALL SIGNIFICANT FINDINGS (POSITIVE OR NEGATIVE), AND RECOMMENDATIONS FOR CORRECTIVE ACTION WILL BE PROVIDED TO THE UNIT, MSC, AND MEF COMMANDER WITHIN 14 DAYS OF COMPLETION.

4.D.1. SUPPLY, MAINTENANCE, MAINTENANCE MANAGEMENT, AND ARMS AMMUNITION AND EXPLOSIVES (AA&E) WILL BE GRADED AND RECEIVE STAND-ALONE SCORES. AN OVERALL UNIT SCORE WILL NOT BE CALCULATED.

4.D.2. PERFORMANCE INDICATOR THRESHOLDS. THREE DISTINCT PERFORMANCE INDICATOR CATEGORIES WILL BE USED.

4.D.2.A. COMPLIANT 100%-90% ACCURACY

4.D.2.B. COMPLIANT (DEGRADED) 89%-70% ACCURACY

4.D.2.C. NON-COMPLIANT 69%-0% ACCURACY

4.E. FOR ASSIST VISIT ANALYSIS CONDUCTED BY FSMAO WESTPAC, THE PLAN OF CORRECTIVE ACTION ENDORSEMENT WILL BE FORWARDED TO III MEF G-4 OR MCBJ G-4 THROUGH THE CHAIN OF COMMAND WITHIN 60 DAYS FOLLOWING RECEIPT OF THE FINAL ANALYSIS REPORT.

4.E.1. FOR FORMAL ANALYSIS, THE ANALYZED UNIT COMMANDER WILL SUBMIT AN ENDORSEMENT DETAILING A CORRECTIVE ACTION PLAN ON ANY NEGATIVE FINDINGS AND OUTLINE ACTIONS TO BE TAKEN TO PREVENT RECURRENCE. THE ANALYZED UNIT WILL ALSO RECEIVE A SURVEY TO MEASURE THE VALUE/CONDUCT OF THE FSMAO ANALYSIS.

4.E.2. THE ENDORSEMENT WILL BE FORWARDED TO HQMC DC I&L (LPC) VIA THE UNIT'S CHAIN OF COMMAND WITHIN 60 DAYS.

4.E.3. A COPY OF THE REPORT, ALONG WITH UNIT ENDORSEMENT, WILL BE PROVIDED BY THE FSMAO OFFICE TO THE MARINE CORPS LOGISTICS COMMAND (MCLC) FOR MARINE CORPS-WIDE TREND ANALYSIS PURPOSES.
